ECO-EFFICIENCY AWARD

Information; Terms & Conditions; Application

1. INTRODUCTION

The New Zealand Institute of Food Science and Technology (the Institute or NZIFST) INDUSTRY AWARDS are intended to recognize excellence and leadership in innovation and quality in the New Zealand food industry, to promote and foster these qualities and to enhance the Institute's involvement with industry.

2. PURPOSE OF THIS AWARD

The **Eco-Efficiency Award** recognises businesses achieving environmental resource efficiencies along with waste reduction.

Businesses working to improve resource and waste management efficiencies bring about benefits that enhance our Economic, Social, and Environmental responsibility.

Examples of activities

Changes in processing or practices or the introduction of innovative technologies leading to:

- significant water savings and/or liquid waste reduction
- significant reductions in solid waste disposal
- significant reductions in energy use and greenhouse gas emissions
- significant reductions in chemical requirements

3. AWARD RECIPIENT

This award will be presented to a representative of the winning company or site.

4. CLOSING DATE

Application/Nomination Closing Date: 31 March in the year of the award

5. ELIGIBILITY

This Award is open to any food or beverage company manufacturing within New Zealand. Applicants/Nominees do not have to be a member of NZIFST.

6. APPLICATION / NOMINATION

Application may be made by any interested member, in writing, 1000 words or less, plus supporting documents, and accompanied by the relevant completed form. All awards will require a declaration that the facts stated are true. The judging panel has the right, at its discretion to seek independent confirmation of the facts stated in the application.

7. NATURE OF AWARD

- The top three finalists in this award will each receive one ticket to the Awards Dinner.
- The top three finalists in this award will be acknowledged at the Awards Dinner.
- The winner of this award will be announced and will receive a plaque/trophy and \$2000 cash prize.

8. JUDGING

The judging panel for this award will be professional and independent and will comprise at least three (3) senior and renowned members of the food industry who are Fellows of NZIFST or recipients of either the JC Andrews or Distinguished Service awards. Full confidentiality of applications will be maintained.

9. PUBLICITY

The NZIFST reserves the right to use finalists' and winner's citations and photographs for publicity purposes but no information of any confidential nature will be released to the public. Copies will also be provided for the winner's use.

10. REVIEW

This award will be reviewed every two years.

11. DISCLAIMER

- The Awards Selection Committee decisions are final and no correspondence will be entered into.
- Awards may not necessarily be presented in each industry sector each year.
- The Awards Selection Committee reserves the right to limit the number of awards in any one year.

In writing, 800-1000 words, plus supporting documents

- i. The core business or activities of your business, clearly outlining the waste management or environmental plans and policies that identify your waste or resourcing issues *and give examples*.
- ii. The water, energy or waste audits/counts undertaken and the frequency of these *and supply examples*
- iii. Your initiatives or programmes to minimise waste or to improve resource efficiency.
- iv. The waste reductions or resource efficiencies you have achieved (i.e. kg, kw, volumes, cost = savings.) *and give evidence*
- v. How your purchasing decisions support the organisation's waste reduction or resource efficiency objectives *and supply examples*
