What is the New Zealand Institute of Food Science and Technologists (NZIFST)?

The New Zealand Institute of Food Science and Technology Incorporated (NZIFST) is New Zealand's society for food industry professionals, benefiting members and the community through the development and promotion of technical proficiency, ethical practices and communications.

The NZIFST has a membership of over 1100 food professionals. Members include those working in all aspects of food production and processing such as product development, nutrition, microbiology, chemistry, sensory science, marketing, regulation, quality assurance and control, operations management, engineering and research. Our members work for a wide range of New Zealand Food and/or Beverage companies who produce, process or supply foods or food ingredients; or for Universities, Crown Research Institutes or Governmental Departments. NZIFST provides a valuable professional link between the many varied food and beverage related disciplines.

Am I eligible for STUDENT Membership?

Any student enrolled full time in a food science/technology/engineering course at a tertiary institution in New Zealand can join the NZIFST as a STUDENT Member; unless you are an Under/Post-graduate student undertaking the study as part of an employment contract or graduate programme in which case you must apply for "Standard" membership.

What are the Benefits of NZIFST Student Membership?

- You may attend Branch Meetings, Seminars and Conferences, where you will have the opportunity to increase your professional knowledge and to make contact with others employed in the New Zealand Food and Beverage Industry.
- Students get **significant discounts** on NZIFST seminars and conference fees.
- Student members will receive the Institute's journal, **Food New Zealand**, published 7 times per year
- Student members will receive the NZIFST e-newsletter, **NZIFST Nibbles**, published fortnightly
- Students are eligible to compete for **student prizes** at the NZIFST Annual Conference.
- Students will have full access to the **members' only area** on the NZIFST web site containing an expanded range of information and services including a resource library, references, regulatory updates and discussion forum.
- Student members are eligible for **Graduate Membership** – this is a full "Standard" membership for one year after graduation but at the low student membership fee.
- Student members may **advertise for summer work FREE** on the NZIFST website.

The Institute's web site, www.nzifst.org.nz, contains the latest information on up-coming events, opportunities for students and job vacancies as well as the history and goals of the Institute.

What does it cost & how long is my membership for?

Full Student membership is \$42.50 incl GST - this gives you membership through until 31st March 2012. However, students who join at the end of the second semester will receive membership until 31st March 2013.

Subsidies - Massey University Turitea Students pay only \$27.50 incl GST (\$10 MUWN branch and \$5 MU subsidies apply)
Massey University Albany Students pay only \$37.50 incl GST (\$5 MU subsidy applies)

Student membership is only available on an annual basis. To ensure continuity of your membership while you are a student, you must re-apply at the commencement of each University year.

Who is eligible for NEW GRADUATE Membership?

Any new graduate who was a Student Member in the previous year may join as a New Graduate. This is the equivalent of a full Standard membership but is available for only one year and costs only the same as a student membership.

What are my responsibilities as a STUDENT Member?

To obtain membership, students are required to acknowledge that they will abide by the NZIFST Code of Ethics. A copy of the full code of ethics is available from our web-site. In summary, the code states that Members of the New Zealand Institute of Food Science and Technology shall uphold the dignity, standing and reputation of their profession and of the Institute with consumers, industry, government, and society by working to ensure Public Health and Safety, by not acting in a fraudulent or deceptive manner; by ensuring that all products, services or information they provide are lawful, accurate and meaningfully presented; and by acting in a manner which will preserve and enhance the reputation of the industry and the Institute.
